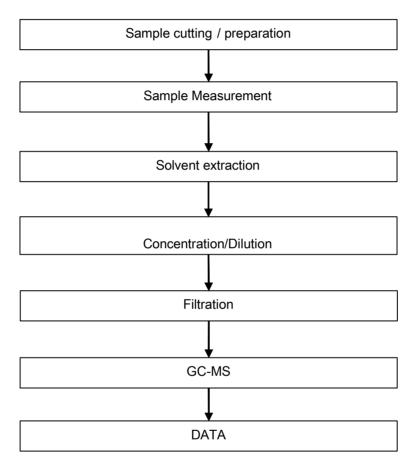

Phthalates Testing Flow Chart






